



## Dance Company Disney Troupe 2023 Information Packet

### **General Info**

We will be taking a group of our dancers to perform at Disney World in Orlando, FL. We will perform a 25 minute holiday show at Disney World (most likely at Disney Springs) the weekend of December 8-10, 2023. Parents will be responsible for traveling with and chaperoning their child for the duration of the trip. Disney offers significantly discounted park ticket packages to the dancers and their families. Participation fees will apply, see below. We are thrilled to offer this awesome opportunity to our dancers ages 8-18. To be eligible dancers must be enrolled in Jazz at LoMastro for 2023-24 Season.

### **Application for Disney Troupe**

Dancers, ages 8-18, are invited to apply for the Disney Troupe. Dancers will be selected for the Disney Troupe based on our knowledge of their dancing ability. Do not submit an application unless you are 100% committed to him/her participating. Please return the signed Disney Troupe Commitment Contract by June 27 along with the \$100 non-refundable deposit. Payment will be processed only if your dancer is selected for the Disney Troupe. If your dancer is not selected, you will not be charged.

### **Rehearsals**

Mandatory Disney Troupe Choreography sessions will be held on Sept 9 & 10 between 9AM-5PM. Rehearsals will be Friday nights between 4:00-8:00 PM (not the full time) from Sep 15-Dec 1 (no Nov 24) at LoMastro. Friday night rehearsal times will vary depending on casting and student class schedules, and will be set by Sep 1. 2 absences will be allowed Sep 15-Dec 1. Absences should be saved for an emergency or illness. If your dancer is absent 3 times the result will be in reduction of stage time and/or removal from the Disney Troupe, without refund. If you know your dancer has a conflict with more than 2 of these dates, please do not allow them to apply. Rehearsals on Sep 9-10 between 9AM-5:00 PM, In-Studio Dress Rehearsal on Dec 3 from 1:00-4:00 PM and the local Performances on Dec 15-16 are mandatory without exception. Disney Troupe will perform as part of our Holiday Showcase at Gorton Center on Dec 15 & 16.

### **Participation Fee**

The participation fee is \$589 which includes rehearsals, costumes, cast t-shirt, and transportation behind the scenes at Disney on our performance day. The non-refundable deposit of \$100 is due with your application and the remaining \$489 will be auto-charged on September 1, 2023.

### **Costumes**

Costumes will be holiday inspired and remain property of LoMastro. Dancers will need to provide their own nude basic/undergarment leotard, tan tights and tan jazz shoes. Select dancers will also need to provide tan character shoes. Select dancers will also need to purchase Hip-Hop sneakers will be \$65 or less.

### **Airfare / Transportation**

Parents will be solely responsible for traveling with and chaperoning their child for the duration of the trip. The intention is that families make a vacation out this opportunity. If you wish to coordinate with another family to chaperone your dancer, you may do so but we will not help organize that. All travel arrangements and accommodations are the responsibility of the individual family. Families are free to choose their own travel dates and accommodations on or off Disney Property. We require that all performers arrive in Orlando no later than 9:00 pm on Friday, December 8.

### **Hotel**

Families are free to stay wherever they wish in Orlando, FL. We encourage families to book accommodations as soon as possible.

### **Disney Park Ticket Packages**

All performers are required to purchase one of the *Disney Performing Arts* Park Hopper or Premium Ticket packages below. You are also able to purchase the performer ticket package for all additional guests

(chaperones, parents, siblings, etc.) at the same performer rate. Selection of your preferred Ticket Package and payment for Ticket Packages will be due August 1, 2023. Ticket Packages must be paid by physical check, or ACH/EFT.



• **Ticket Types**

- **Starter Ticket Package:** This ticket is valid for admission to one of the four Walt Disney World Theme Parks (one Park per day) for each day of this ticket.
- **Park Hopper® Ticket Package:** This ticket is valid for admission to one or more of the four Walt Disney World Theme Parks for each day of the ticket (with the freedom to visit multiple Parks on the same day).
- **Premium Ticket Package:** Tickets include the Park Hopper® Option and Water Park and Sports Option. The Water Park and Sports Option includes Fun visits to additional locations at the Walt Disney World Resort. The number of Fun visits granted is equal to the number of days included in the ticket package purchased. Example: If a guest purchases a 3-Day PREMIUM Ticket, they will be entitled three (3) Fun visits. Fun visits may be used at the following locations: Disney’s Blizzard Beach Water Park, Disney’s Typhoon Lagoon Water Park, r Disney’s Fantasia Gardens Miniature Golf Course or Disney’s Winter Summerland Miniature Golf Course, One (1) round of FootGolf at Disney’s Oak Trail Golf Course.

**Important Notes for 2023**

- To enter a Park, both a reservation and a valid ticket or pass for the same Park on the same date are required. Parks and other offerings may be limited in capacity and subject to limited availability or closure, and Park admission and offerings are not guaranteed.
- The Park Hopper® Option allows Guests to visit more than one Park per day. Guests must make a Park reservation via the Disney Park Pass reservation system for the first Park they plan to visit. After entering that first Park, Guests will be able to visit the next Park starting at 2 PM until each Park’s regularly scheduled closure, subject to the Park’s capacity limitations. At this time, a Park reservation is not required after the first Park, however, reservation requirements are subject to change.
