DANCE COMPANY DISNEY TROUPE 2021 INFORMATION PACKET

General Info

We will be taking a group of our dancers to perform at Disney World in Orlando, FL. We will perform a 25 minute holiday show at Disney World (most likely at Disney Springs) the weekend of December 17-19, 2021. Parents will be responsible for traveling with and chaperoning their child for the duration of the trip. Disney offers significantly discounted park ticket packages to the dancers and their families. Participation fees will apply, see below. We are thrilled to offer this awesome opportunity to our dancers ages 7-18. To be eligible dancers must be enrolled in Jazz at LoMastro for 2021-22 Season. *Note: We'll consider incorporating 6 year old siblings of participating dancers in the performance, although 6 year olds will not be allowed to participate in the Workshop and will have limited stage time during the performance.*

Application for Disney Troupe

Dancers, ages 7-18, are invited to apply for the Disney Troupe. Dancers will be selected for the Disney Troupe based on our knowledge of their dancing ability. Do not submit an application unless you are 100% committed to him/her participating. Please return the signed Disney Troupe Commitment Contract by June 25 along with the \$100 non-refundable deposit. Payment will be processed only if your dancer is selected for the Disney Troupe. If your dancer is not selected, you will not be charged.

Rehearsals

Mandatory Disney Troupe Choreography sessions will be held on Sept 10-12. Rehearsals will be Friday nights Sep 17-Nov 19 at LoMastro and Wednesday, Dec 1 at Gorton Center. Performances will be held on Sunday, Dec 5 at 5:30 and 6:30 pm. Times will vary depending on casting student and class schedules and will be decided by Sep 1. 2 absences will be allowed Sep 10-Nov 19. Absences should be saved for an emergency or illness. If your dancer is absent 3 times the result will be in reduction of stage time and/or removal from the Disney Troupe. If you know your dancer has a conflict with more than 2 of these dates, please do not allow him/her to apply. Rehearsals on Sep 10-12 and Dec 1 and the Performances on Dec 5 are mandatory without exception.

Participation Fee

The participation fee is \$545 which includes rehearsals, costumes, cast t-shirt, and transportation behind the scenes at Disney on our performance day. The non-refundable deposit of \$100 is due with your application and the remaining \$445 will be auto-charged on September 1, 2021.

Costumes

Costumes will be holiday inspired and remain property of LoMastro. Dancers will need to provide their own nude basic/undergarment leotard, tan tights and tan jazz shoes. Select dancers will also need to provide tan character shoes.

“Disney Dancin' Workshop” - Tentative and Optional

At this time Disney is not scheduling workshops. They expect workshops will be available for our group in December, but are not able to commit yet. If we are able to add a workshop for our dancers it will be optional and there will be an added charge like around \$40.

Airfare / Transportation

Parents will be solely responsible for traveling with and chaperoning their child for the duration of the trip. The intention is that families make a vacation out this opportunity. If you wish to coordinate with another family to chaperone your dancer, you may do so but we will not help organize that. All travel arrangements and accommodations are the responsibility of the individual family. Families are free to choose their own travel dates and accommodations on or off Disney Property. We require that all performers arrive in Orlando no later than 9:00 pm on Friday, December 17.

Hotel

Families are free to stay wherever they wish in Orlando, FL. We encourage families to book accommodations as soon as possible.

Disney Park Ticket Packages

All performers are required to purchase one of the *Disney Performing Arts* Park Hopper or Premium Ticket packages below. You are also able to purchase the performer ticket package for all additional guests (chaperones, parents, siblings, etc.) at the same performer rate. Selection of your preferred Ticket Package and payment for Ticket Packages will be due August 15, 2021. Ticket Packages must be paid by check.



• Ticket Types

- **Starter Ticket Package:** This ticket is valid for admission to one of the four Walt Disney World Theme Parks (one Park per day) for each day of this ticket.
- **Park Hopper® Ticket Package:** This ticket is valid for admission to one or more of the four Walt Disney World Theme Parks for each day of the ticket (with the freedom to visit multiple Parks on the same day).
- **Premium Ticket Package:** Tickets include the Park Hopper® Option and Water Park Fun & More Option. The Water Park Fun & More option includes visits to additional locations listed below at the Walt Disney World® Resort. The number of visits granted is equal to the number of days included in the ticket package purchased.

Important Notes for 2021

- To enter a Park, both a reservation and a valid ticket or pass for the same Park on the same date are required. Parks and other offerings may be limited in capacity and subject to limited availability or closure, and Park admission and offerings are not guaranteed.
- The Park Hopper® Option allows Guests to visit more than one Park per day. Guests must make a Park reservation via the Disney Park Pass reservation system for the first Park they plan to visit. After entering that first Park, Guests will be able to visit the next Park starting at 2 PM until each Park's regularly scheduled closure, subject to the Park's capacity limitations. At this time, a Park reservation is not required after the first Park, however, reservation requirements are subject to change.

All persons attending the trip must return a signed Waiver. All parents as well as any chaperones attending the trip must complete the waivers ASAP after casting is announced and no later than August 1, 2021. We expect this will be updated prior to our group trip, but it will need to be signed no later than August 1 so that we can order our tickets. Disney requires at least 2 weeks to verify everyone from our group has completed the online waiver prior to allowing us to purchase park tickets.
